10.2 Approval of Resolution #21-22:15 Declaring Property as Exempt Surplus

On February 6, 2018, the Azusa Unified School District’s (“District”) Board of Education (“Board”) established the District’s facility advisory (7-11) committee consisting of not less than seven (7) nor more than eleven (11) members (“Facilities Advisory Committee” or “7-11 Committee”) to compile information and forward a report to the Board about the uses of its real property and surplus space. Pursuant to Education Code sections 17388, et. seq., the Facilities Advisory Committee was asked to review the former Sierra High School/Adult Education Center, located at 1134 South Barranca Ave. Glendora, California 91740 (“Property”). After a series of meetings, the Facilities Advisory Committee determined the amount of surplus space, established and circulated a priority list throughout the community, and made a final determination regarding the limits of tolerance of use of the space. At its meeting on April 27, 2018, the 7-11 Committee held a public hearing in compliance with the Education Code requirement to receive public comment on its final report. The Board has received the 7-11 Committee’s final report and the minutes from the public hearing. The District has reviewed the inventory and uses of its real property and has determined that the Property is currently not needed and will not be needed for future school facilities and classroom space. Resolution #21-22:15 will declare the Property as exempt surplus property pursuant to Education Code section 17455, et. seq., and Government Code section 54221(f), and authorize the Superintendent or his designee to take all necessary actions to further the intent of the Resolution.

Due to a large number of existing extended vacancies, and the recent vacancy in the Accounting Supervisor position, Fiscal Services enlisted the services of Ryland School Business Consulting in order to maintain operations, provide excellent service to our school sites and internal departments, accomplish future goals, and complete a mandatory financial system conversion. The terms of the contract will allow the District to use the consultant on an as-needed basis. The amount of the projected budgetary impact is calculated based on the

consultant working every work day through the end of the fiscal year. The savings from the various vacancies will significantly, if not entirely, off-set the cost of the contract. The projected cost of \$84,000 will ensure that critical fiscal services tasks will continue to be completed until the department is fully staffed.

State law requires all public schools receiving state funding to prepare and distribute a SARC. A similar requirement is also contained in the federal Elementary and Secondary Education Act (ESEA). The purpose of the SARC is to provide parents and the community with important information about each public school. No less than triennially, the Board must review and compare the contents of Azusa Unified School District's SARCs to the template approved by the State Board of Education.

Recommendation: It is recommended the Board of Education approve the 2021 SARC for all TK-12 schools.
