10.3 Approval of Azusa High School's (AHS) Participation in Junior Reserve Officer Training Corps (JROTC) High School Encampment

The JROTC High School Encampment is located in Irvine, California, and will take place May 30 - June 01, 2025. This is an excellent opportunity for the 25 students attending the AHS JROTC program to practice “hands-on” leadership while interacting with other California JROTC students in an atmosphere that takes advantage of facilities available only at a military installation. Emphasis will be on further developing teamwork, self-discipline and citizenship in a safe, caring, fun, and supportive environment. Hands-on training will include confidence building through the use of mountaineering techniques (rappelling and mountain climbing), map reading/orienteering and leadership development with a leadership confidence course, water safety training, and inter school competitive events. The students will be supervised by instructors and chaperones from AHS. The District's JROTC members have attended the High School Encampment since 2017. Board of Education approval is necessary since the trip requires overnight travel.

Traveling Tidepools will offer small group assemblies that increase student literacy around science, including marine biology and ecosystems, while promoting critical thinking and deepening understanding of human impact on marine environments. In November of 2024 the Azusa Unified School District's ("District") Board of Education ("Board") approved the execution of a purchase and sale agreement ("Agreement") for the sale of the District's surplus real property located at 1134 Barranca Ave. in the City of Glendora known as the former Sierra Elementary School site ("Property"), to Melia Homes, Inc. (known as "Melia"). During its Feasibility Review Period, Melia encountered a number of delays in receiving feedback on its predevelopment application, due to backlogs with staff at the City, and the Board agreed to extend the Feasibility Review Period via the First Amendment approved in January of 2025. Since the execution of the First Amendment, the District has been made aware of a potential additional development fee to be levied by the City, which would impact the feasibility of the transaction. The District, with the assistance of its broker and legal counsel, has negotiated the Second Amendment to the Agreement to further extend the Feasibility Review Period in order to seek clarification regarding the nature and impact of this potential fee. The Second Amendment to the Purchase and Sale Agreement will amend the following terms of the Agreement: 1. The termination date of the Feasibility Review Period, as set forth in Section 2.2 of the Agreement, will be extended from February 27, 2025 to April 11, 2025. 2. The Agreement will be reinstated by both parties after having terminated by its own terms before a regular Board meeting could be convened.

site (“Property”), to Taylor Morrison of California, LLC (known as “Taylor Morrison”). During its Feasibility Review Period, Taylor Morrison encountered a number of delays in receiving feedback on its predevelopment application. The Board agreed to amend the Agreement extending the Feasibility Review Period, to account for these unexpected delays. Now, Taylor Morrison is requesting the ability to demolish the obsolete school buildings located on the Property prior to closing escrow on the site. The Second Amendment to the Purchase and Sale Agreement will amend the following terms of the Agreement: 1. The Buyer will be allowed to enter the Property and demolish the existing school buildings at its own cost.


