11.6 Approval of the Agreement between Azusa Unified School District (AUSD) and California School Inspection (CSI)

Williams Facility Inspection Tool (FIT) inspections are due every year and the results are noted in District School Accountability Report Cards (SARC). Williams FIT inspections are a result of the class-action lawsuit (Williams v. California) that claimed the state's poorest children were being denied equal access to the basics of a quality education. For school districts, Williams FIT inspections are to be completed annually by either District staff, or an agency, and by the county office of education. Though the county office of education completes FIT inspections, they only inspect 25% of each of the selected sites. The District is responsible for completing a thorough FIT analysis for all sites each fiscal year. This proposal obtains the services of CSI to complete a thorough Williams inspection of all sites that are currently being utilized by the District. CSI will provide the District with one electronic copy of the FIT report for each school and all the photographs taken related to FIT. The District has been working with CSI since 2020.

13.1 Approval of Resolution #21-22:36, Providing for the Issuance of Series D of the District's Measure K General Obligation Bond

On November 4, 2014, the voters of the District approved Measure K authorizing the District to issue up to \$92,000,000 in aggregate principal amount of bonds for authorized projects. The Board of Education is requested to approve the above-referenced resolution authorizing the District to issue its fourth and final series of bonds under the November 4, 2014 authorization in an aggregate principal amount not exceeding \$14,000,000. The bonds will be sold and issued by the District. Isom Advisors, a Division of Urban Futures, Inc. will serve as municipal advisor to the District. Orrick, Herrington & Sutcliffe LLP will serve as bond counsel and disclosure counsel. RBC Capital Markets, LLC will serve as the underwriter. The Board of Education is asked to approve the resolution referenced above to effect the issuance of the bonds and approve various documents and actions, as follows: 1. Resolution: The resolution authorizes the issuance of the bonds and establishes parameters for the terms thereof, approves the forms of and authorizes the execution and delivery of the financing documents (including the Bond Purchase Agreement and the Continuing Disclosure Certificate), approves the form of and authorizes the distribution of the Official Statement (in preliminary and final form), and sets forth the security provisions for the bonds and the covenants of the District to bond owners. 2. Bond Purchase Agreement: The Bond Purchase Agreement will specify the purchase price of the bonds to be paid by the underwriter, the interest rates, maturity dates and principal amounts of each maturity of the bonds, the date, time and place of the closing of the bond issue, the allocation of the expenses incurred in connection with the bond issue, the parties' representations to and agreements with each other and the conditions which the District must satisfy before the underwriter becomes obligated to purchase the bonds. 3. Continuing Disclosure Certificate:

Federal securities laws indirectly require school districts to disclose and annually update certain financial and operating information relevant to the security and repayment of bonds. The Continuing Disclosure Certificate contains the undertakings of the District to provide the ongoing disclosure in the form of annual reports and event notices. 4. Official Statement: The Official Statement (in its preliminary and final form) is used to provide information to investors and prospective investors about the District and the bonds. The bonds constitute securities for purposes of state and federal securities laws and, therefore, the offering and sale of the bonds through the Official Statement is subject to certain provisions of such laws, including, importantly, the anti-fraud laws. The Official Statement sets forth information about the terms of the bonds, the security for the bonds, the sources and uses of the proceeds of the bonds, the District and the tax base of the District, the documents under which the bonds are issued, and the tax-exemption of interest on the bonds.

13.2 Approval of Agreement between Azusa Unified School District (AUSD) and Enterprise

It is recommended the Board of Education approve an open-ended equity lease with Enterprise. An open-ended lease allows for flexibility and will help the District move toward hybrid and electric vehicles. Using the open-ended equity lease model, the District can leverage the same annual capital to replace five vehicles that cash purchases could have only replaced with one. Enterprise has been awarded the Sourcewell contract, which Azusa USD is currently a member of. Using the Sourcewell contract allows Enterprise to compare all makes and manufacturers to best fit the district's needs. Enterprise will order vehicles needed on the District's behalf, negotiate all incentives, upfit the vehicles, and deliver the vehicles to Azusa USD.

13.3 Approval of Consultant Agreement between Azusa Unified School District (AUSD) and Daniel Menyon

In February 2022, the Board of Education approved the contract between AUSD and Ryland School Business Consulting. Through this agreement, Ryland sent Daniel Menyon to work on site. Mr. Menyon has been assisting with filling in the gaps caused by vacancies, assisting with the 2022-2023 budget development, 2021-2022 budget clean up, and BEST system integration and implementation. Through the agreement with Ryland, the District

agreed to an hourly rate of \$175. Understanding the need for the services, but being consistent with the financial implication, the Business Services team continued to negotiate the terms of the contract. Ryland has agreed to allow the District to go into a contract directly with Mr. Menyon, which will allow the District to continue to receive the needed services, but pay a lowered hourly rate of \$90 per hour. The projected budgetary impact of \$28,000 is calculated based on Mr. Menyon working through the end of the fiscal year, starting in May through June 30, 2022. The previous agreement was also through June 30th. Upon Board of Education approval, the agreement with Ryland will terminate. Though this contract is through June 30th, it is not anticipated that services will be needed for the duration, as we are actively working to fill all current vacancies.

Recommendation: It is recommended the Board of Education approve consultant agreement between AUSD and Daniel Menyon.
