

Scope of Services for Azusa High School 2023-2024

Instructional and Leadership Support Service Descriptions and Deliverables

School Leadership Team (SLT)

The team will be composed of teacher leaders from subject area departments, administration, coaches, and counselors. The team will meet on-site during the 2023-2024 school year.

Deliverables

Deliverables include:

- Development of a School Implementation Plan. The SLT will collaboratively analyze data, select an academic/social-emotional learning focus area(s), and identify student success indicators, staff practices, school supports, evidence of learning and timelines.
- Strategic instructional leadership calendaring and support planning with customized support services.
