All districts participating in the Program have agreed to deliver to all terms and conditions set forth in this Memorandum in order for AUSD to fully comply with all Program eligibility requirements.

The duration of the MOU will be for the duration of the grant funding term of July 1, 2020 -December 31, 2022, unless otherwise modified or terminated by either party 30 days following the effective date of such written notice.

For the Grant Term ending December 31, 2022, the Foothill Consortium has been awarded \$661,857, a portion of which shall be made available to District, per allocation attachment. The grant payment will be dispersed to the Foothill Consortium pursuant to receipt of fully executed Memoranda of Understanding from all members of the Consortium and a signed Grant Award Notification (GAN). All funds must be expended within the dates designated and for not more than the maximum amount indicated on the GAN. Funding for subsequent Grant Term(s) will be subject to performance data and CDE review.
