Teachers will be provided the opportunity to enhance student learning through interactive, differentiated learning options. The District will pay ECS \$8.00 per student per session for each student that has a recoverable absence and attends the Academic Attendance Recovery Coordinated Program (AARC). For the purposes of payment herein, attendance shall be determined at the time roll is taken at each session. AUSD worked with ECS in the 2018-2019 school year. **Recommendation:** It is recommended the Board of Education approve the agreement between AUSD and ECS.
