| Azusa Golden Days Committee | One year | Typically meets the third Wednesday of the month at 7:00pm. Committee discusses the planning of Azusa Golden Days. |
| Azusa Parks and Recreation Commission | One year | Typically two meetings a month (the 1st and 3rd Thursday) at 6:00pm. |
| Los Angeles County Committee on School District Organization | One year | There are no meetings involved. Serves as the Board's voting representative for the annual election of members to the L.A. County Committee on School District Organization. |
| Joint Board of Management of the SGV ROP/TC | Two years | Typically monthly Board Meetings (the 4th Thursday) at 5:30pm. |
| LACSTA (Voting Representative) | One year | Typically monthly meetings the last Monday of the month at 5:15pm if executive member, 6:00pm if not. The objective and purpose is to preserve, advance, and improve public schools in LA County and to provide a means of networking with other trustees. |
| Two Plus Two Committee | One Year | Typically, monthly meeting, on Wednesday mornings around 10am, between the District and the City to update and collaborate. |
| Wellness Committee | One Year | Typically meets 5 times a year, on Friday afternoons. Wellness Committee meets to promote the link between student health and learning. |
