Bylaw 9100: Organization

Each year, the Governing Board shall hold an annual organizational meeting. In any year in which a regular election of district Board members is conducted, the organizational meeting shall be held within a-15-day period beginning from days following the date upon which a Board member elected at that second Friday in December after the regular election takes office. During non-electionall other years, the meeting shallmay be held within the same 15-day period on the calendar. any date in December, but no later than December 20th. (Education Code 35143)

The day and time of the annual meeting shall be selected by

During any year in which a regular election is conducted, the Board, at itsthe regular meeting held immediately prior to the first daysecond Friday in December, shall select the day and time of the organizational meeting. For any other year, the day and time of the 15-day periodorganizational meeting shall be selected at the last regular meeting held immediately before the annual meeting. On behalf of the Board, the Superintendent shall notify the County Superintendent of Schools of the day and time selected. Within 15 days prior to the date of the annual meeting, the clerk of the Board, with the assistance of the Superintendent; shall notify in writing all Board members and members-elect of the date and time selected for the meeting.—(Education Code 35143)

At this meeting the Board shall:

- 1. Elect a president, vice president, and a clerk from its members following the protocol listed under Election of Officers below
- 2. Appoint the Superintendent as secretary to the Board
- 3. Authorize signatures-
- 4. Approve a schedule of regular meetings for the year and a Board governance calendar stating the time when the Board will address important governance matters
- 5. Designate Board representatives to serve on committees or commissions of the district, other public agencies, or organizations with which the district partners or collaborates-
- 6. Review and/or consider resources that define and clarify the Board's governance and leadership roles and responsibilities including, but not limited to, governance standards, meeting protocols, Board rules and bylaws, and other Board development materials

Election of Officers

The Board shall each year elect one of its members to be clerk. This member shall be one who previously has not served in office, unless all the Board's members have previously served in office. After serving one year as clerk, the elected member shall serve one year as vice president of the Board, and the following year as president of the Board.

No Board member shall serve more than one consecutive year in the same office.

The Board of Education shall rotate Officer duties and Board Member seats on a yearly basis at the Organizational Meeting. The Officers and Seats are as follows:

- 1. Board President
- 2. Board Vice President
- 3. Board Clerk
- 4. Board Member Seat 1
- 5. Board Member Seat 2

After serving one year, the Offices/Seats will shift as follows:

- Board President \rightarrow Board Member Seat 2
- Board Vice President → Board President
- Board Clerk → Board Vice President
- Board Member Seat $1 \rightarrow$ Board Clerk
- Board Member Seat $2 \rightarrow$ Board Member Seat 1

When a new Board Member is elected/appointed to the Board of Education, they will begin in Board Member Seat 2. If two new Board Members are elected/appointed to the Board of Education, they will begin in Board Member Seat 1 and Board Member Seat 2 and in a random manner it will be determined who will begin in Board Member Seat 1 and who will begin in Board Member Seat 2. If three new Board Members are elected/appointed to the Board of Education, they will begin in Board Member Seat 1 and who will begin in Board Member Seat 2. If three new Board Members are elected/appointed to the Board of Education, one of the three new Board Members will be elected to Board Clerk. The other two Board Members will begin in Board Member Seat 1 and Board Member Seat 2 and in a random manner it will be determined who will begin in Board Member Seat 1 and Board Member Seat 2 and in a random manner it will be determined who will begin in Board Member Seat 1 and Board Member Seat 2 and in a random manner it will be determined who will begin in Board Member Seat 1 and Board Member Seat 2 and in a random manner it will be determined who will begin in Board Member Seat 1 and Who will begin in Board Member Seat 2.

This process shall be followed unless the Board approves a deviation from the process.

The election of Board officers shall be conducted during an open session of the annual organizational meeting.
