1.Increase teachers' knowledge and capacity to engage students with cognitively challenging tasks that increase student participation and cognitive engagement in class. 2.Strengthen teachers' ability to use literacy in their content area to increase student literacy skills overall and increase content learning using district level data to drive instructional decisions with grade level content. 3.Create and sustain teams involved in cycles of inquiry to empower teachers to understand what students are doing during instruction related to cognitive engagement, discussion of topics in content areas and use of content area literacy. 4.Build teachers' capacity to notice, analyze, and respond to students' thinking.

The service will provide development and support of student engagement in content area literacy strategies to improve student comprehension of content.
