

CONSULTING AGREEMENT  
THIS CONSULTING AGREEMENT (“the Agreement”) dated this  
20-day of September 2021

BETWEEN:

Azusa Unified School District, 564 South Citrus Ave., Azusa CA 91702  
(the “Customer”)

-AND-

Debra Amos of 2161 Bogie Drive, La Verne, CA 91750  
(the “Consultant”)

BACKGROUND:

- A. The Customer is the opinion that the Consultant has the necessary qualifications, experience and abilities to provide services to the Customer.
- B. The Consultant is agreeable to providing such services to the Customer on the terms and conditions set out in this Agreement.

In Consideration of the matters described above and of the mutual benefits and obligations set forth in this Agreement, the receipt and sufficiency of which consideration is hereby acknowledged, the Customer and the Consultant (individually the “Party” and collectively the “Parties” to this Agreement) agree as follows:

**Services Provided**

1. The Customer hereby agrees to engage the Consultant to provide the Customer with services (the “Services”) consisting of:
  - School Nutrition administrative advice for the National School Meal Programs.
2. The Services will also include any other tasks that the Parties agree on. The Consultant hereby agrees to provide such Services to the Customer.

**Term of Agreement**

3. The term of this agreement (the “Term”) will begin on the date of this Agreement and will remain in full force and effect for 1 year, subject to earlier termination as provided in the Agreement. The term of this Agreement may be extended by mutual written agreement of the Parties.
4. In the event that either Party wishes to terminate this Agreement, that Party will be required to provide 30 days notice to the other Party.

**Performance**

5. The Parties agree to do everything necessary to ensure that the terms of this Agreement take effect.

**Currency**

6. All monetary amounts referred to in this Agreement are in USD (UD Dollars).

**Compensation**

7. For the service rendered by the Consultant as required by this Agreement, the Customer will provide compensation (the "Compensation") to the Consultant of \$125.00 per hour plus compensation for any expenses incurred in connection with providing the services of this agreement.
8. The Compensation will be payable on a monthly basis, while this Agreement is in force.

**Capacity/Independent Contractor**

9. In providing the Services under this Agreement it is expressly agreed that the Consultant is acting as an independent contractor and not as an employee. The Consultant and the Customer acknowledge that this Agreement does not create a partnership or joint venture between them, and is exclusively a contract for service.

**Notice**

10. All notices, requests, demands or other communications required or permitted by terms of this Agreement will be given in writing and delivered to the Parties of this Agreement as follows:
