## PROVISIONING CONTRACT OF SERVICES

This Provisioning renewal contract is entered into this day of July 2023, by and between, here Refrigeration Control Company Inc. in after referred to as "Provisioner", and the Azusa Unified School District, hereinafter, referred to as "District". Provisioner and District agree as follows:

- 1. Offer periodic maintenance, repair and service of all refrigerators and freezers.
- 2. Schedule. Each site, including the warehouse, will receive (1) maintenance visit a year.
- 3. Benefits and Requirements:
  - a. Perform the contract and complete in a workman like manner all the work required in connection with the Request for Proposal issued on March 17, 2023, for freezer and refrigeration preventative maintenance and repair services in strict conformity with contract documents.
  - b. Ensure all documents as indicated in RFP are current. This includes insurance documents as specified in the RFP.
- 4. Indemnification. Provisioner shall indemnify, defend, and hold District (and all staff and board members) harmless from and against all damage, loss, injury, liability, expense, liens, claims, costs (including attorney's fees) and assertions arising out of Provisioner's conduct or improper procedures, or from Provisioner's breach or default under this Contract. The indemnity, however, shall not apply to the extent (and only the extent) that District was negligent in its handling or subsequent use of the food product following proper procedures and delivery by provisioner.
- 5. To the extent that there are any inconsistencies or differences in any terms or provisions contained in the District's Agreement when compared to any terms or provisions contained in any attachment or addendum to the District's Agreement requested by the Provisioner, the terms and provisions of the District's Agreement shall be controlling and shall supersede any terms and provisions in the Provisioner's attachment or addendum.
- 6. Term. This contract shall cover the period for the 2023-2024 school year effective July 1, 2023, through June 30, 2024 and shall be renewable for one year upon mutual agreement of parties.
- 7. Pricing. (Minimum 1 hour labor charge)

Regular time rate \$146.50 per hour, billed in ¼ hour increments, 7am-4pm Mon.-Fri.

Overtime rate is \$209.75 per hour, billed in ¼ hour increments, after 4:00pm on weekdays and on Saturday's 8:00am-5:00pm.

Certified payroll regular rate (prevailing wage) \$207.00 per hour, 7am-4pm Mon.-Fri.

Certified payroll overtime rate (prevailing wage) \$300.50 per hour, after 4:00pm on weekdays and on Saturday's 8:00am-5:00pm.

Certified payroll Weekend/Holiday rate (prevailing wage) \$347.25 per hour, after 5:00pm Saturdays, all day Sunday and holidays.

8. Default. If the Provisioner be in default under any term of this Contract, District shall have the right to terminate this Contract upon 30 day's written notice to Provisioner (with opportunity to cure). If provisioner does not cure such default within 30-day period (or, if the default relates to an improper procedure, such cure period can be accelerated in District's reasonable discretion), this Contract shall be automatically terminated, with the exception of Section 5 hereof which shall survive. The foregoing termination remedy shall be in addition to any other rights District may under law equity.
