



<b>Title of Service/Workshop:</b> Nutrient analysis and updating nutritionals for scratch cooked recipes, employee training and professional development, wellness policy triennial assessment as required by USDA			
<b>What service will be provided?</b> Monthly nutritional and meal pattern analysis, updating recipes and products in Titan, work with new vendors to create NSLP compliant documentation and product formulation statements.			
<b>Kitchen Infrastructure and Training (KIT) funding categories.</b>			
Evaluate and score the current District Wellness policy utilizing the WellSAT 3.0, provide triennial assessment report and recommend areas that need revision to committee, conduct required WellSAT-1 interviews with the District head of curriculum and school principal.			
<b>How will this service improve District/student outcomes?</b>			
The District was a recipient of KIT funds. Part of these funds have to be used to provide training to Nutrition Services employees for the 2024-2025 school year. My School RD will provide much needed training to cover current meal pattern requirements, recipe standardization as the District embarks on implementing more starch cooking.			
All nutritionals will be updated and current in the new point of sale system. School Nurses will be able to use this information to access carb counts and ensure meals are available to students that require special meal accommodations.			
<b>How will we know when the consultant's objective/s are met?</b>			
Information and updated menus with nutrients will be available online, Wellness policy triennial assessment will be submitted to CDE after committee and Board presentation, employees will be able to share and implement what they are learning throughout the school year. We will begin offering more scratch cooked meals.
