# <u>Amber Fish</u>

Hello, thank you for hearing me out today. I really want to commend the Board of Education and Superintendent and his cabinet for having a meeting for DI parents at Hodge. However, I wanted to echo a couple of comments made at the parent meeting to the Board of Education. We are requesting additional support. Possibly an aide because instead of having a 26 to 1 ratio, our First-Grade class is looking at 30 students to one ratio. Also, more students packed into a classroom was a little discouraging because of COVID. We are still worried about following social distancing. We would like to suggest possibly getting air purifiers in the classroom. I was excited about the smaller class sizes for the Dual Immersion program. Dual Immersion takes a lot of work for students whose first language is English like my son. I was excited to see him go back in person after a year of distance learning. I was hoping the smaller class size would make up for the learning loss from distance learning. With a class of 30 instead of a class of 15, I am not sure that that learning loss will be addressed. The overcrowded classroom is very concerning to me. We are going to be adding a Fifth-Grade class to the DI program and this should have been addressed. I know that you were unable to find qualified candidates and I am hoping that this call goes out sooner in order to find next year's sixth grade DI teacher. Our DI teachers are amazing. My son has had great teachers and I look forward to interacting with them as time goes on. Finally, I want to thank the Board of Education for asking such great questions during the study session.

I appreciate them asking for more information and clarity on the survey. I agree the numbers do not fully show what the parents want. Thank you.

# <u>Cecilia Ford</u>

Good Evening Superintendent Ortega, Cabinet, and Members of the Board of Education, my name is Cecilia Ford. I am the second VP/Chief Union Steward of CSEA Azusa Chapter 299 and I represent the largest essential group of people within our district, the Classified Employees. I am here tonight to speak about the Classified Staff that pays for health insurance offered through AUSD. We hear all the time, "Thank you for all you do. We appreciate you. You're valuable to our district." How truly valuable are we and how truly appreciated are we? So valuable and appreciated that most classified employees who have health insurance through AUSD can barely afford it. The cost of health insurance keeps going up, and yet the district contribution does not. Folks have to choose whether to put food on the table, keep a roof over their heads, or pay for health insurance that the State of California says that we must have. Individuals must work two and three jobs to supplement their income because what they earn with AUSD is not enough. Most of their earnings go to health insurance. When does that individual have time for their family if they are constantly working? When does a child see their parents? There is not enough time in the day for their precious gems in their life because they must make up for the lack of earnings they receive from AUSD. We lose great employees because they cannot afford to pay for the health insurance and must seek to find other jobs that will help them cover the cost. We have potential employees not wanting to join our district because of the disclaimer that they are told to read on all job postings. They would rather go elsewhere and feel more appreciated by receiving better benefits. AUSD's contribution to health care is one of the lowest in the surrounding area. The district is well aware of this and there is still no change. We will continue to stand up here and repeat repeatedly what our requests are and we will not stop until there is a significant change. Thank you for your time and consideration in hearing what I have to say. Come on Azusa Unified, let's make a change.

# <u>Selisa Loeza</u>

Good evening Superintendent, Cabinet, and Board of Education. I am one of the families that were affected by the changes in the Dual Immersion program at Victor Hodge. First, I would like to thank the Superintendent and Cabinet for giving the parents a presentation and a space to speak. I understand that the District is hopeful about the program. However, as a parent and a previous elementary school educator, my trust has been lost in the leadership in the program for a lack of planning and not noticing lower enrollment. My trust has been broken in that if an unexpected vacancy is to happen again, our children are at risk of more changes in the future. My child cried about changing his teacher. Just after the changes were initially made, another student was added to my son's class for a total of 30 students. When District expectations should be 26 to 1. I feel our students are losing critical attention needed in an overcrowded classroom of COVID. Secondly, the issue is not just about hiring but retaining teachers. Although teachers may have agreed to these changes, did they really have the option to say no? This concerns me about the mental health of teachers. Teachers are expected to set up new classrooms, say goodbye to students, create, and learn a new curriculum. How does our District plan to retain our teachers for the long term? My request is a teacher aide in all classrooms for a minimum of 4 hours a day. Moving classes to wider rooms. Purchasing a minimum of two air purifiers per classroom. If the Board of Education is unwilling to provide the air purifiers, I have gathered a group of parents willing to contribute. I suggest that we consider reducing Kinder DI to one class if staff is an issue. Finally, in regards to last week's Study Session on Reorganization, I appreciate the Board of Education's requesting more clarification on the true representation of the community. Model four shows it will not result in a loss of students. My children are in TK and First grade. If Model 4 is chosen, it will not benefit my

children. Model four will affect my children and the Dual Immersion program. This will result in the loss of my children to this district and possibly others in a similar situation. Thank you.




# 13.1 2020-2021 Academic Achievement Results






2020-2021 Academic Achievement: Azusa USD Local Assessment Results








