- **1. Charles Lee Elementary = Client, The BMX Freestyle Team LLC = Artist.** Client Agrees to pay the total due on this contract for the show scheduled. All payments are expected to be submitted in the following manner unless other terms of payment were previously discussed and have been stated in the previous conversations. If these conditions cannot be met consult us at the BMX Freestyle Team and other terms can be discussed. It is herein understood that the company or individual that is responsible for payment of this event is also solely liable for the conditions of the performance area. Some basic conditions should consist of a clean, smooth and level show area (Playground or blacktop work perfect). The BMX Freestyle Team will assist as well and will have brooms or leaf blowers on hand.
- **2.** The agreement of the Artist to perform is subject to proven detention by sickness, acts of god, equipment malfunctions and other legitimate conditions. The BMX Freestyle Team reserves the right to reschedule any show due to schedule complications.
- **3. NO DEPOSIT IS REQUIRED!** In the event that the Client cancels there will be no cancellation fees, but we do appreciate giving us an alternate date or a two-week notice if possible. In case of an outdoor event, Client is responsible for payment in full, regardless of cancellation due to weather if we are set up and ready to go. (A discount may be applicable). Artist will not perform under conditions that may be hazardous to themselves or others in the audience. If the show is scheduled for an outdoors performance, the client may seek an indoor option and a modified version of the show can be performed in the space provided.
- **4.** The foregoing plus any attached riders, including technical requirements, constitutes the agreement between the Client and the Artist. This contract shall be expounded according to the laws of the State of California.
- **5.** By signing or making any payment on this Contract you are indicating your agreement with all terms and conditions of this contract.
- **6. Charles Lee Elementary & if noted the Schools District** will be named as additional insured on the certificate provided by the BMX Freestyle Team in the amount of \$2,000,000.00/Per Occurrence with a \$4,000,000.00/Aggregate.
- **7. Show Details-On Monday, April 28th** the BMX Freestyle Team will perform **One (1) 40-minute-long BMX Stunt Show** for **Charles Lee Elementary**. Showtime 8:30am.
