# 13.3 Approval of the Proposal between Azusa Unified School District (AUSD) and Willdan Energy Solutions

Some of the District's heating, ventilation, and air conditioning (HVAC) equipment is at or is near its energy-efficient life. A full central plant feasibility study is needed to determine the remaining life of existing equipment and correct energy deficiencies. The District issued a Request for Proposal (RFP) in March 2022, for the energy service project development and implementation of Board approved ESSER III expenditure plan related to infrastructure and energy conservation project. Four responses were received, reviewed, and ranked based on the noted ranking criteria listed in the RFP. The response receiving the highest ranking was Willdan Energy Solutions. Upon Board approval, Willdan Energy Solutions will complete a central plant feasibility study for the entire district which will cover HVAC, windows, and doors. Willdan's goal is to combine cost savings, operational improvements, and infrastructure upgrades to provide facilities that meet the District's set energy savings goal and create uniformity throughout the District. The report will have a preliminary basis of the design concept, preliminary energy savings analysis, and one Design-Build proposal for the recommended solution. **Recommendation:** It is recommended the Board of Education approve the proposal between AUSD and Willdan Energy Solutions.

The agreement is to audit the current fiscal year ending June 30, 2022, with an option to extend for two (2) additional years, in accordance with general accounting office standards for financial and compliance audits, and shall include, to the extent applicable, the audit procedures recommended by the Department of Finance, State of California, as detailed in the Department's most recent publication entitled Standards and Procedures for Audits of California Local Educational Agencies.

# 13.5 Approval of Resolution #21-22:31, Authorizing Filing of Application(s) for the California Preschool, Transitional Kindergarten(TK) and Full-Day Kindergarten Facilities Grant Program

Education budget trailer bill AB 130 signed by Governor Newsom in July 2021 added \$490 million of funding for California State Preschool Program and TK facilities in Fiscal Year 2021-2022. This funding is to provide one-time grants to school districts to construct new school facilities or retrofit existing school facilities for the purpose of providing TK and full-day kindergarten classrooms. While filing an application does not guarantee funding; if an application is approved, the district will be awarded a reservation of funds and will have 12 months to submit the required approvals such as the California Department of Education (CDE) plan approval and/or Division of the State Architect (DSA) approved plans. The deadline to apply for this round of funding is April 30, 2022. This resolution authorizes district staff to file applications for funding in the specified grant program and is providing certification that the district plans to continue to provide Transitional Kindergarten and Full Day Kindergarten services. In order to move forward with the application Student Facility Programs (SFP) process for this grant, it requires the submission of the attached resolution as part of the packet.
